DISTRICT CHOIR ENTRY FORM

INSTRUCTIONS: Please follow these guidelines in preparing your entry form. Remember that your paperwork must be **Posted Electronically by September 7, 2006** in order for your entries to be accepted and your students allowed participation in this contest.

1. Attach a photocopied copy of your current TMEA membership card to the new State required "Auditions Process Entry Cover Sheet" and a hard copy of your computer entry form.

2. Payment for the audition is **\$15** per student. The fee is payable to "**Music Region XVII - TMEA**" on a school or Booster Club check only. (Remember that personal checks are not acceptable and your school district will not be billed). If your district is unable to provide a check by this date, you must include a dated photocopied copy of your request for payment. This form will be used to confirm your students' eligibility to participate in this audition. **Your school must have some (form of payment) or (documentation of intention to provide payment) submitted before the audition date.**

3. Each entered student must have on file a signed student **Conduct and Medical Release Form**.

4. **REMEMBER** - While you may enter as many students as you wish, their chances are much better if you try to balance the sections you are entering.

5. There is **NO** Sight-reading Audition at the district level.

6. District Alignments for 2006-2007 will be chosen on a student-by-student basis. The students will be assigned a random number by the computer. The top half will be assigned to Zone 1 and the bottom half will be assigned to Zone 2.

7. **ALL entries must be completed by ON-LINE REGISTRATION. Your information must be sent using the TMEA approved and supplied format.**

INSTRUCTIONS: These are addendums to the original handbook as voted by the membership at the Fall meeting 2006.

DISTRICT CHOIR ALTERATIONS

1. Girls taken from audition process at District
 - a. 50% of registration numbers
 - b. Maximum of 72 singers
 - c. Equal representation to be taken from each zone.

2. Men taken from audition process at District
 - a. 50% of registration numbers
 - b. Sections with less than 60 registrants are excused
 - c. Sections excused will be announced at close of electronic registration period.

3. All sections
 - a. Every listed song will be used as a cut.
 - b. Cuts will be roughly one minute per song.
 - c. Minor adjustment will be made for musical content.
 - d. Cuts to be picked by Region Chair, Vice Chair and Host.

Elected Offices:

1. Vice Chair – Rob Phillips
 - a. Organize Judges for contests.
 - b. Operational approval of judge panels.
 - c. Tabulations assistant organizer.
 - d. Region Clinic clinician optimization.

2. All Volunteer positions are now elected named offices.
 - a. Hosts
 - b. Judge organizers
 - c. Clinician organizers
 - d. Section leaders

REGION CHOIR AUDITION ALTERATIONS

1. Cuts should approximately one minute per song
2. All songs will be represented
3. Audition will contain sight-reading
4. Audition will be held as a unit of sing and then sight-read
